1. Objective of the meeting

Kenya Civil Aviation herein referred to as KCAA invited bid for the refurbishment and conversion of mezzanine floor to a gym at JKIA tower building.

	Clarifications Sought by bidders/Validations by KCAA	KCAA's Response
1.	The drawing is not provided in the bid document	The drawing has now been provided with clarifications.
2.	Where will the washrooms for the projects be positioned?	This will be agreed upon with the bidder who will be awarded the contract and project team (provided in the tender document)
3.	Will there be a ceiling to be done in the whole room?	Yes. Gypsum ceiling shall be done.
4.	There is no provision for firefighting equipment in the BQs	A temporary one for the time being by the organization.
5.	Are there other requirements apart from what has been provided by mandatory requirements	Should present a Gantt chart (project schedule for 3 months).
6.	In the tender document, appendix 35.2 indicates firms under youth with AGPO certificates can participate. But preliminary No. 7 states women	The advertisement is indicated as for citizen contractors, and this will still apply. Reference on AGPO is an error.
7.	Is the moonlight vents going to be addressed?	Yes. The ones that will not be flashing with the ceiling, simply as described in the provided documents.
8.	Is the floor going to be level with the platform?	No. The structure is old, and we cannot add some dead loads. In addition, we cannot take them off because of the existing concrete class. Although in the changing rooms, we are going to, because of gulley traps and plumbing works.
9.	Is roof leakage part of the scope	Yes. Where the stormwater pipe is discontinued, but if we observe some leakages during the rainy season authority addresses them.
10.	Is the water storage provided for?	Yes. Two tanks as specified in the document.
