The Authority has received requests for clarification on the above stated tender from some interested candidates.



1.	The tender document indicates the title of tender is proposed construction of perimeter fence while the tender data sheet indicates that it is proposed construction of a wall. Please clarify?	The correct title of the tender is "proposed construction of perimeter fence at Central Transmitting Station in Mlolongo" as indicated in the tender advertisement.
2.	In the tender document, appendix 35.2 indicates that firms registered under youth with AGPO certificates can participate while the tender advert states that the firms should be registered under women.	The tender is reserved for firms registered with AGPO under women as indicated in the tender advertisement.
3.	The tender securing declaration form is missing?	The tender securing declaration form is available on page 63 of 105 in the tender document.
4.	Will KCAA provide security for the project during contract implementation?	No. The successful bidder will be required to safeguard their own equipment and bidders must include the cost in their bill of quantities..
5.	Will KCAA provide water for the construction?	No. The successful bidder will outsource their own water and bidders must include the cost in their bill of quantities.
6.	The pre-bid and site survey meeting was attended by one hundred and ten (110) attendees representing various bidders.
